### IDEA Organizes Patch Test Reading Workshop

**Related to the IDEA sponsored Extended Fragrance Ingredients Surveillance Study (EFFIS) a patch test reading workshop was organized at Malmö University hospital on September 20, 2024, as kind of kick-off event for launching the first round of collecting clinical data.**

To ensure establishing reliable clinical data, a central element of EFFIS is the harmonization of processes and ensuring rigid quality control.

The focus of the workshop, addressing involved clinicians and nurses from the engaged clinics, was standardization of loading of patch test chambers by different techniques as well as reading of patient reactions, with focus on differentiating irritation from weak sensitization reactions.

## ECHA RAC adopts Opinions on the CLH proposals for seven fragrance ingredients

**Following the plenary meeting of 27 and 28 November 2024, the ECHA RAC has adopted Opinions classifying seven fragrance ingredients as Repr. 1B; H360FD**

IFRA has taken the lead on behalf of industry and has provided extensive comments on the CLH proposals during the public consultations held last year and on the draft opinions presented by the ECHA RAC Rapporteurs during several meetings of the ECHA RAC.

# Ingredient defence and Regulatory Affairs

## (EU) Regulation 2024/2865 amending the CLP

**(EU) Regulation 2024/2865** (<https://eur-lex.europa.eu/eli/reg/2024/2865/oj>) amending the EU CLP regulation (CLP revision) was finally published on 20th November 2024 in the Official Journal of the EU and entered into force on 10 December 2024.

IFRA's priority rests on getting robust criteria for the grouping of substances and requesting a derogation from the general rules for classification of plant-based extracts are reflected.

The revised CLP regulation also includes several measures for regulators to encourage the speedier adoption of CLH in the future.

It covers advice on the new hazard criteria for endocrine disruptors (ED) for human health or the environment; persistent, bioaccumulative and toxic (PBT); very persistent and very bioaccumulative (vPvB) substances; and persistent, mobile and toxic (PMT); very persistent and very mobile (vPvM) substances:

### IFRA at A.I.S.E. event: Panel discussion at the European Parliament

#### **Advocating for a proportionate framework in the context of the Detergents Regulation revision**

IFRA participated in A.I.S.E.'s event at the European Parliament, title 'Our Clean Future: The indispensable role of Europe's cleaning and maintenance products industry', highlighting the essential role of Europe's cleaning and maintenance products industry.

The panel, featuring Hans Ingels (European Commission), Prof Dirk Bockmühl, and Dr Andreea Capilna, emphasized the importance of high-level hygiene, especially in healthcare settings.

Discussions focused on improving the Detergents Regulation by addressing inconsistencies, fostering innovation, and ensuring better enforcement through tools like the Digital Product Passport.

Securing proportionate biodegradability requirements under the Detergents Regulation remains a key priority for IFRA. IFRA will actively collaborate with A.I.S.E. during the upcoming trilogue negotiations, set to begin in January 2025.

### IFRA at the 5th Commission Workshop on Safe and Sustainable by Design (SSbD)

**Presenting IFRA case-study on methyl salicylate, highlighting the need to maintain a risk-based approach and adopt a more streamlined framework.**

On 5 December, IFRA participated in the 5th SSbD Workshop hosted by the European Commission.

Annika Batel (BASF) and Aurelie Perrichet (IFRA) presented a case study on methyl salicylate, showcasing the fragrance sector's experience and insights.

Key recommendations included the need for a streamlined, risk-based approach to safety, a less resource-demanding framework, and a holistic view of sustainability.

The workshop, attended by over 300 people, including representatives from various Directorate-Generals of the European Commission, national authorities, and stakeholders, is part of the SSbD framework 2-year testing phase, which runs until 2024 ahead of its finalization in 2025.

**Certificate course on sustainable perfumery 'The Art of Crafting Fragrances and Nurturing Careers' at Hindu College, Delhi University, India.**

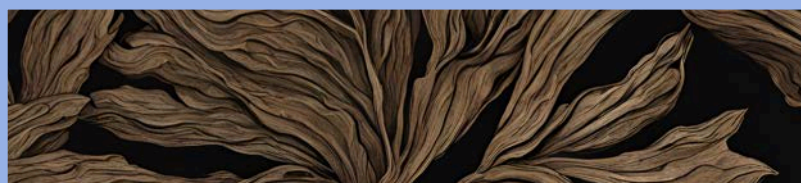
The perfumery course is scheduled for commencement in January 2025 with the orientation for the candidates selected for this course.

IFRA in India with knowledge partners, Hindu College, Delhi University; Sant Sangneria Foundation for Health and Education; CSIR- Central Institute of Medicinal Aromatic Plants (CIMAP); FICCI; and International Society of Perfumer-Creators is hosting this noble industry led initiative, first of its kind in this region.

The significant feature of this perfumery course is that its content has been designed and curated by factoring in the inputs from the industry to deliver "Industry ready skilled professionals" with a sound scientific base. Takasago, Robertet, Givaudan, Ultra International Limited, Norex, Eternis, ITC, and Vimal Life Sciences Pvt. Ltd. are the prominent industry partners associated with this course.

Other salient features are emphasis on Comprehensive learning and Global perspective, planned in physical mode spread over 41 weeks in two modules to include classroom learning, industry internship and institutional attachment.

## News by region: Latin America (LATAM)

### Mercosur

#### Public consultations on cosmetics list

Brazil has launched consultations on restricted substances, concluding Mercosur updates.

ANVISA – Brazil's National Health Surveillance Agency – opens [Public Consultation No. 1305/2024](#) to update Brazil's restrictive list for cosmetics, with implications for Mercosur harmonization.

The comment period runs from January 7 to March 7, 2025. This public consultation in Brazil marks the final stage in a series of consultations already completed in Argentina, Paraguay, and Uruguay, all of which relate to the proposed MERCOSUR draft resolutions:

- § P. RES. N° 03/24: "Mercosur Technical Regulation on the list of substances that personal hygiene, cosmetic, and perfume products must not contain, except under specified conditions and restrictions" (repealing GMC Resolutions N° 24/11 and 35/22).
- § P. RES. N° 04/24: "Modification of GMC Resolution N° 62/14.

As with previous consultations, IFRA will collaborate with its National Associations (in Brazil, ABIFRA) and local partners to submit fragrance industry comments to the ANVISA public consultation.

### Brazil

#### Establishment of national inventory of chemical substances

The new law sets framework for assessing and controlling chemicals.

[Law No. 15.022/2024](#) introduces Brazil's National Inventory of Chemical Substances to mitigate health and environmental risks.

Published on November 14, 2024, this landmark law mandates the registration of chemicals produced or imported in Brazil in quantities exceeding one ton annually. The law creates a public database aligned with GHS standards and establishes committees to oversee its implementation. Authorities have three years to develop the necessary systems, after which manufacturers and importers must comply with reporting requirements. Regulation details are expected within 180 days (i.e. by May 13, 2025).

### FCA Is Well Connected with the New Administration and Congress

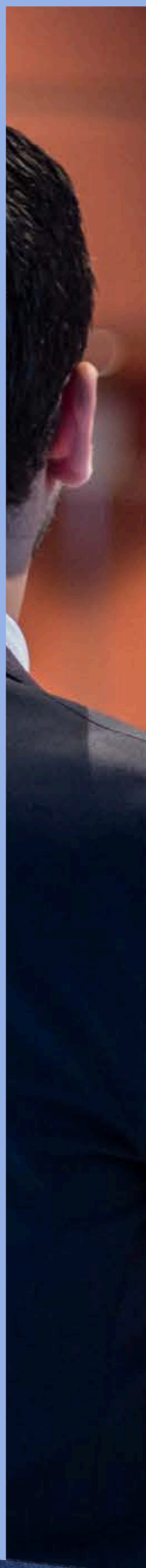
**The association has established direct, meaningful relationships and remains well-positioned to advocate on behalf of the U.S. fragrance industry.**
