IFRA-Cosmetics Europe webinar on Regulatory developments around para-cymene

This was a webinar for IFRA and Cosmetics Europe members on 26 March.

This webinar was in-depth update on the regulatory developments surrounding paracymene. Speakers discussed the recent opinion adopted by ECHA's Risk Assessment Committee (RAC) proposing its classification as reprotoxic category 1B, its impact on Natural Complex Substances (NCS), and the implications for the cosmetics industry.

Updates on our contributions within the European Commission Working Group on Cosmetic Products were also given.

Furocoumarins

Furocoumarins: Scientific Rationale supporting revised IFRA policy published

The scientific documentation supporting our second leave-on threshold of 5 ppm for furocoumarins has just been published. Both concentration and UVA exposure are critical factors in potential skin effects. Thresholds can be identified to effectively manage risks and ensure safe formulation.

This research is the result of collaboration within the IFRA Furocoumarin Stakeholder Group. This publication will serve as the key reference in the IFRA FC Standard.

International Symposium on the Sustainability of the Fragrance and Flavor Industry

Shanghai, May 13

The one-day symposium is a joint effort of IFRA-IOFI together with Chinese Association of the Fragrance Flavour and Cosmetic Industries (CAFFCI) and will be held in the Courtyard hotel by Marriott Shanghai Central on May 13. Chinese local fragrance and flavour (F&F) companies including about 80 audiences will attend the workshop.

IFRA and IOFI Presidents, Alexander Mohr and Sven Ballschmiede will introduce the IFRA-IOFI Sustainability Charter 2.0 as well as key activities from the two international associations. Speakers from Chinese academies, international and local F&F companies will present the Chinese sustainability policies and plan, life cycle assessment tool and their current best practices. Chinese local F&F companies are welcome to voluntarily sign the IFRA-IOFI Sustainability Charter.

Animal testing

European Commission Roadmap towards phasing out animal testing in chemical safety assessment

Activities by the European Commission to develop the Roadmap towards phasing out animal testing in chemical safety assessment are intensifying, as the publication is planned for early 2026. IFRA continues to actively engage in relevant stakeholder events to contribute to this evolving discussion.

The Animal-Free Chemical Safety Assessment Conference took place in Brussels on 4–6 March 2025; a flash report is available here. On 16–17 June 2025, the European Commission, in collaboration with ECHA, will host a third workshop to present and consult on draft recommendations and milestones of the Roadmap: link.

The report of the European Commission's December 2023 workshop on the Roadmap has been published <u>here</u>.

Recommendations from the June 2024 multi-stakeholder roundtable, which included IFRA's participation, have been published in ALTEX: <u>link</u>.

A robust and comprehensive Roadmap is critical to maintaining fragrance innovation in the medium to long term, avoiding unnecessarily conservative safety assessments, and ensuring the continued defence of fragrance ingredients.

IFRA at JAG meeting


IFRA hosts roundtables to discuss the fragrance value chain and EU Regulations

In the framework of its Joint Advisory Group (JAG) meeting on 10 and 11 April 2025, IFRA was pleased to host two roundtables that brought together a wide range of stakeholders from the fragrance value chain, along with policymakers from the European Commission and the Council.

The first session explored key regulatory developments impacting the fragrance value chain in the early months of the new EU legislative cycle (2024–2029). Discussions centred on the hazard-based approach and ingredient classification under the EU's CLP Regulation, the evaluation of the current Cosmetic Products Regulation, as well as the revision of the Detergents Regulation.

The second panel focused on the European Commission's upcoming proposal to revise the REACH Regulation under the Chemicals Industry Package, expected in late 2025. Speakers examined how this initiative is likely to affect the fragrance value chain, with a focus on balancing regulatory ambitions with industry competitiveness.

Farmers, scientists, industry awareness program in vetiver cluster, Cuddalore

In April 2025, IFRA, FICCI, CIMAP, and Ultra International hosted an awareness workshop for 200 farmers, processors, and entrepreneurs involved in vetiver cultivation in Pondichéry and Cuddalore.

The workshop addressed post-cultivation challenges, scientific and technological interventions, and resource management strategies. Presentations included responsible sourcing practices, the application of IFRA's Green Chemistry Compass Tools, and guidance from CSIR-CIMAP scientists on distillation techniques and chemical analysis. Field demonstrations showcased improved harvesting, transportation, and storage methods to reduce waste and enhance productivity.

IFRA Discusses New Biodiversity Act with Indian Authorities

India's amended Biodiversity Act (2023) and new Biodiversity Rules (2024) are awaiting operational guidelines from the National Biodiversity Authority (NBA).

To address concerns raised by domestic and international stakeholders, IFRA met with NBA's Secretary in Chennai.

At the meeting, IFRA secured confirmation that the NBA will present on the amended framework and respond to industry questions during a FICCI-hosted webinar planned for 6 June 2025, supporting clarity and ease of business in the sector.

Strengthening Fragrance Collaboration in Brazil

IFRA President engages national associations, visits Natura, and joins LATAM Regional Committee.

This month, IFRA President Alexander Mohr was in São Paulo for a week of strategic meetings and engagements across Brazil's vibrant fragrance value chain.

The visit began with high-level discussions with five leading national associations: ABIQUIM (Brazilian Chemical Industry Association), ABIHPEC (Brazilian Association of the Personal Hygiene, Perfumery and Cosmetics Industry), ABC (Brazilian Society of Cosmetology), ABAS (Brazilian Aerosol Association), and ABIPLA (Brazilian Association of the Cleaning Products Industry). These exchanges helped align on shared priorities, regulatory issues, and future collaboration—while offering valuable insights into the scale and complexity of Brazil's upstream and downstream sectors.

Alexander Mohr also toured the facilities of Natura, a global leader in sustainable beauty, to see their innovation and responsible fragrance practices in action.

The week concluded with a hybrid meeting of the IFRA Latin America Regional Committee, held at the IFRA Latin America regional office in São Paulo, which is co-located with valued National Association member ABIFRA. Committee members reviewed implementation progress on IFRA's strategy, identified regional priorities, and set the course for the coming months.

FCA Secures Tariff Exemption for 50+ Fragrance Ingredients

FCA successfully advocated to exclude key fragrance-related materials from President Trump's new tariffs.

FCA shielded the fragrance industry from new U.S. import costs by securing exemptions for more than fifty key materials from President Trump's April 2 "Liberation Day" tariffs. Leveraging White House relationships honed across the Obama, Trump, Biden, and now second Trump administrations—and the rapid coordination of trusted advisors—FCA delivered this win and continues to engage on the Trump Administration's broader economic agenda.

FCA Fragrance Encapsulates Exclusion in California

FCA led a coalition advocating for the exclusion of certain microplastics – including fragrance encapsulates – from a California bill seeking to ban microbeads

Late last year, the California legislature introduced a bill to ban microbeads in a wide range of consumer products, including personal care and cleaning products. As a result of FCA's efforts, the author amended the bill to clarify that non-abrasive microbeads in personal care and cleaning products – including fragrance encapsulates – are no longer subject to the ban.
